For the last three years, I have been privileged to travel to New York City to represent our fire department in a 5k run/walk in honor of Stephen Siller, a fire fighter from Squad 1 located in Red Hook, Brooklyn. This fire fighter died at the World Trade Center while saving lives. He was off duty and went to help out anyway. He could have went about his business because he had already left the fire house before the American Airlines Flight 11 struck the North Tower at 8:46AM. However, he turned his vehicle around and headed for the World Trade Center and his untimely death. I heard one of his brothers answer the question why would he do this, by saying "that is just the way Stephen was."

I went to New York City in 2002 for the first time to participate

in this event mostly for myself. I had a personal goal to find something other than a FDNY line-of-duty section on my website to help me deal with this devastating loss of emergency workers and occupants of the world trade center.

I had actually passed on going to Colorado Springs to attend the ceremony that Jay Jahnke's name was place on the line-of-duty memorial wall. Jay died in the line of duty one month after Stephen. I felt that I was able to deal with Jay's death much better than the World Trade Center disaster.

When I arrived and participated in the event I knew I had done the right thing. The spirit of Stephen Siller's family was more than over whelming. This is a family that just a year before had suffered a great loss and was taking on the monumental task of organizing this major event. For the third year in a row the event was very successful. The proceeds go to a cause that Stephen was involved with in prior to his death. I have decided to do a profile on Stephen Siller in this column within the next several months and will give you many more details of his life and his family.

There are several things about this event that are very impressive. The 5k Run/Walk starts at the entrance of the Brooklyn Battery Tunnel and ends directly across the street from where the mighty World Trade Center once stood. Once inside the tunnel there are 343 FDNY Fire Fighters in dress uniform lining the tunnel with American Flags. This year, they added Fire Fighters from all over the country carrying banners with pictures of the faces of the 911 Fire Fighters.

The Siller Family's display of courage has prompted me to look at them as my new heroes.
